# **Representing our Community**


- How is Manningham affected?
  - 7 years of construction impacts
  - Over 1,200 jobs gone
  - Industrial Business Precinct erased
  - Loss of open space Bulleen Park and Koonung Creek Linear Park
  - Significant loss of vegetation & environmental impacts
  - Eastern Freeway widening delivers more cars and trucks
  - Increase in noise and pollution
- Ensure no-net loss to our community





### **Council's Core Principles**

- **avoid** socially and physically dividing communities
- improve local connectivity and access to jobs and social services
- Ensure displaced local businesses and employees are **proactively supported** prior to any acquisition
- maintain general **amenity** and minimise disturbance to existing residential and environmentally sensitive areas
- provide complementary projects that **promote active & sustainable transport** (walking & cycling)
- **No net-loss** of community facilities during or post-construction
- **No tolls** on the Eastern Freeway
- Upgrade Templestowe Road

### **Open Space & Environment**

- Protect Bulleen Park
- Koonung Creek corridor
  - Excessive construction area
  - "undergrounding" of creek
- Loss of trees, vegetation and open space
- Protect significant River Red Gum
- Protect Bolin Bolin Billabong
- Manage floodwaters





### **Traffic & Transport**

- Design of Dedicated Busway (1 bus every 30 seconds)
- Upgraded Doncaster Park & Ride (multi deck) & new Bulleen Park & Ride
- Impact to Austin & Avon Streets in Bulleen
- Walking & cycling paths and bridges
- Upgrade of Templestowe Road
- Managing traffic impacts / road closures during construction





### **Design, Economic & Social Impacts**

- Design of Manningham Road interchange
- Impact to Bulleen Industrial Precinct and loss of local businesses
- Securing new sites for industrial land (i.e. Websters Road, Templestowe)
- Freeway widening impacts near Estelle Street, Bulleen
- Noise walls (up to 10 metres high)
- 40 metre high ventilation shafts
- Visual impacts and Urban Design Strategy
- Social Impacts






### **Planning Scheme Amendment**

- Draft Planning Scheme Amendment (GC98)
  - Apply several Overlays (DDO14, DDO15 & SCO)
  - Effects up to 250 existing properties in Bulleen
  - To protect the tunnel 15 metres below homes
  - To permit works within the entire project corridor

### • Planning approval required for:

- A new building (or extension to an existing building) 5 or more storeys in height without a basement;
- Excavation works beyond 2.5 metres below surface level;
- New buildings & works (only in shallow areas of tunnel)

- The EES outlines the proposed project design and contains mitigation and management measures for the project
- Consider the EES as the project's "Planning Permit"
- Inquiry and Advisory Committee (IAC) appointed to consider the EES & public submissions (commencing 25 July 2019 at the Veneto Club, 191 Bulleen Rd, Bulleen)
- Minister for Planning (Richard Wynne MP) to assess the EES in late 2019


